#### **Devils Lake Conservation/Aeration Project**

All equipment is fully operational and maintained. There are no issues and the PO'S are good at the bottom of the lake.

#### **Devils Lake Aquatic Vegetation Management**

Currently completing DEQ permitting and associated materials prior to initiating our comprehensive vegetation management plan. Preliminary permit has been competed and sent to DEQ for comments. DLWID should hear results in 2-4 weeks after Discharge management Program. Notices will be sent out to the public when Drones are used for viewing.

#### **Devils Lake Flood Protection**

State agencies are requiring a biological assessment be performed prior to submitting the application. Campbell Environmental is currently performing the work.

#### Water Quality Briefing

Dissolved oxygen levels are over 98% lake wide. No visible problematic algae in the water column. Representatives from the Federal EQA and Oregon DEQ will be meeting with District staff to complete a comprehensive biological assessment as part of a national effort to determine the overall health and status of lakes around our country. The work is scheduled to begin in June 2022 with the final report being issued in 2024.
