Budget Presentation

Tina French called the Budget Meeting to order.

Josh Brainerd, Budget Officer, presented to the DLWID Members and Budget Committee Members the Budget Draft for Fiscal Year 2022-2023.

Josh Brainerd explained the areas of interest for this fiscal year are the, Marina, Maintenance of the Blue Heron building, grading of the parking lot, vegetation, algae concerns, and monitoring of all changes.

The Board has received \$310,000 from Representatives Gomberg, submitting a request from the State, for vegetation management.

There was discussion with the Board Members concerning how to use this money to benefit all areas concerned especially the vegetation and algae monitoring services around the lake.

Tina French recapped the discussions:

Plans for a temporary office and meeting room

Rebuilding of new facility

Vegetation management acres to treat

Funds for experimental control of weeds around the docks and purchasing weed rakes, construction barriers and fencing etc.

Possibly purchasing a boat to secure access to the lake.

Communications Report

Staff has communicated with DLNA to include DLWID outreach efforts into their association news releases. Staff has developed and forwarded to news outlets a news release regarding DLWID being selected for the National Lakes Assessment.

Social Media Activity Report

Devils Lake Conservation/Aeration Project

All equipment is fully operational and maintained per schedule

Devils Lake Aquatic Vegetation Management

Currently completing DEQ permitting and associated materials prior to initiating our comprehensive vegetation management plan. Preliminary permit has been completed and sent to DEQ for comments. With a very fast turnaround, DEQ has provided DLWID the approved permit. There is a contractor on tap around the end May.

Devils Lake Flood Protection

Campbell Environmental is currently completing the Corps/DSL/DEQ permit Biological Assessment. They are coordinating with Civil West to provide a design drawing for the temporary sediment laydown storage pad, due West of the D River outlet. A coordinating meeting with DLWID< Campbell, and Civil West will be held on May 10 2022. Eight agencies are involved, 1,700 cubic yards will be removed.

Action Items

Civil West to complete design for sediment laydown pad.

Water Quality Briefing

Dissolved oxygen levels are over 97% lake wide. No problematic algae have been identified within the water column.

Devils Lake has been selected to receive a Federal EPA/Oregon DEQ National Lakes Assessment, beginning in June 2022 with work completion expected in 2024, culminating in a comprehensive final report. This selection is a significant benefit for DLWID, Lincoln City, and Lincoln County. As assessment of this magnitude is currently not within DLWID current budget scope and is expected to provide necessary background for future grants and other funding opportunities. Additional information regarding the array of benefits to DLWID will be received during this spring/summer. This is a great opportunity and funding opportunity.

New Business

General discussion of marina parking lot maintenance

To improve the grading that is needed the cost will be around \$8,900.

General discussion of boat slip rentals and temporary office facilities.

Temporary office and meeting space is needed while the current building is removed and rebuilt.

A master plan will need to be submitted to the City Planning.
