Campbell Environmental is currently completing the Corps/DSL/DEQ permit Biological Assessment. They are coordinating with Civil West to provide a design drawing for the temporary sediment laydown storage pad, due West of the D River outlet. This sediment pad location drawing is due by mid-June. A Coordinating meeting with DLWID, Campbell, and Civil West was held on 5/10/22. Another coordinating meeting between the parties will be held during June.
