Compressor is operational with no known problems. Diffuser count was full. All diffusers are present and operational.

Devils Lake Aquatic Vegetation Management

Milfoil Management Update: No change from July 2021. Milfoil appears to be concentrated in the canals near the D River. A summary of last year's treatment is posted on www.dlwid.org as well as our Social Media outlets.

SePro has been contacted to re-map the lake by species presence and volume. Awaiting a date for the work to be performed.

Josh Brainerd commented they are working on getting out the information concerning responsibility to the vegetation in the lake as to what needs to be done and what is the proper way to deal with it.

Devils Lake Flood Protection

DLWID staff has net with Civil West Engineering in Newport regarding taking on the proposed Dredging project in the D river. Permitting costs have been determined to be between 5-12 thousand dollars to obtain the necessary permits to dredge the lake where tidal sand has historically been building up. We are still awaiting a cost estimate from a specialty contractor to perform the dredging itself.

A consensus of the Board members was to move forward with getting information.

No change from last month. Dissolved Oxygen levels are very healthy at over 95% on the lake bottom lake wide with very little visible algae

at-this-time. E Coli sampling for 2021 is complete with all results well below the low-risk threshold. A yearly summary will be completed and posted once the data has been organized.
